**Sub: Provisioning of 2 Mbps Internet Leased Line to 79 universities under UGC INFONET project of INFLIBNET, Ahmedabad – reg.**

INFLIBNET, Ahmedabad intimated to EB-II, Gujarat Circle, BSNL to provide 2Mbps Internet Leased Lines (ILL) to 77 universities immediately where BSNL could not provide 10 Mbps ILL till date, as all existing 2Mbps Internet Leased Line provided by M/s ERNET Ltd to INFLIBNET will be discontinued on 31<sup>st</sup> May, 2010.

As M/s ERNET India Ltd is using BSNL local lead and NTU/Modem for 2 Mbps Internet Leased Lines to these universities, we may use same local lead and modem and provide 2Mbps to universities before 31<sup>st</sup> May, 2010 on temporary basis.

Bulk Advice Notes for 2Mbps Internet Leased Line for 77 universities has already been issued through TVARIT and Advice Note for 10Mbps Internet Leased Line for all these 77 universities are cancelled. Bulk circuit ID for 2Mbps ILL is GUJ/79###/INFLIBNET3/0003 (70 universities) and GUJ/79###/INFLIBNET1/0001 (7 universities- Batch ID 4). List of 77 universities is enclosed as per Annexure – 1.

However, the ultimate aim is to provide 10Mbps ILL to these universities as soon as possible and therefore, preparation of infrastructure for provision of 10 Mbps ILL should be continue and not to be stopped. As soon as the infrastructure is ready for provision of 10 Mbps ILL to these universities, same may be intimated to EB-II cell, Gujarat circle so that necessary Advice Note can be issued in TVARIT.
