JOB DESCRIPTION FOR LIBRARY & INFORMATION SCIENCE PROFESSIONALS: The incumbent will be a member of team of young library and information science professionals responsible for interacting with and assisting the university libraries in their computerization work, creation of machine readable databases, working knowledge in library automation software, creation and development of digital libraries and institutional repositories, digitisation of library resources, knowledge of bibliographic formats such as CCF, MARC21, etc. electronic publishing, knowledge of library networks and consortia, e-books, Web.20, Library 2.0 services and should be well-versed with current developments in ICT applications in libraries. Besides, incumbent would be required to conduct training programmes for library professionals in computerized library operation, arranging seminars / conferences / workshops etc. under the guidance of the Director.

JOB DESCRIPTION FOR COMPUTER SCIENCE/ENGINEERING PROFESSIONALS: The incumbent will be a member of a team of computer professionals involved in development of library related software and setting-up of network facilities. The candidate should possess good knowledge of modern proprietary and open source operating system. He / she will be involved in development of various web-based services using development tools, creating and developing web content and its management and constantly evolving new tools and their application for Indian academic community.

GENERAL CONDITIONS

1. Candidates with requisite qualifications acquired from recognized university/institution need only apply. Mere possession of advertised qualifications and experience does not entitle a candidate for interview.
2. Number of positions advertised may increase or decrease.
3. Only post qualification experience will be counted.
4. Candidate applying on deputation basis is required to forward his / her application clearly mentioning the NOC/Clearance from their present employer along with copies of last five years ACRs/APARs, copy of last Payslip and Vigilance Clearance from the current employer. The deputation will be allowed to those candidates who are already working in same grade pay or next below grade pay. During the employment on lien no deputation allowance will be paid and leave salary, pension & gratuity contribution, etc. will be borne by the candidate only and appointment will be treated as fresh appointment with probation of one year. Deputation will be granted at the discretion of competent authority of this Centre.
5. Candidate applying under reserved category must produce caste certificate as per Govt. of India rules and should carry title that the certificate is valid for All India Employment and in case of OBC (non-creamy layer) certificate issued in current year is valid failing which applicant will be treated in open category and no relaxation in age limit will be allowed.
6. Written Test may be conducted for any/all posts advertised.

7. The grade pay mentioned against the post is on provisional basis and may be changed.
8. The posts carries usual allowances as per Govt. of India rules as applicable from time to time. The selected candidate will be covered under New Pension Scheme only.
9. At present the place of posting is at Ahmedabad but the selected candidates are liable to be posted for work any where in India as and when required.
10. Candidates working in Govt. / Govt. Undertaking /Autonomous bodies/Universities must forward their applications through proper channel.

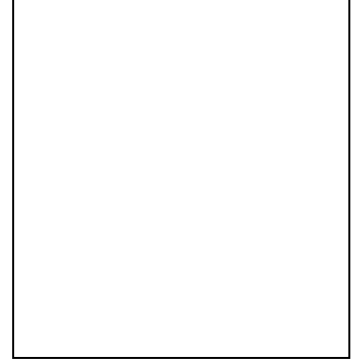
