The Director briefed the members of the Finance Committee Centre that the Networked Digital Library of Theses and Dissertations (NDLTD) which is an international organization dedicated to promoting the adoption, creation, use, dissemination, and preservation of electronic theses and dissertations (ETDs) has offered to host the International Conference at INFLIBNET Centre during 2023. The members after detailed discussion agreed to the proposal of sanctioning an amount of Rs 30.00 Lakh from the saving of the Centre to organize the same but opined that the expenditure from internal resources should not exceed 50% of the total expenditure.

36.7 Civil Repairs of the Institute Building

The finance committee agreed to the proposal of the CPWD regarding repairs of the building for approaching any institute like IIT/NIT or any Govt. Engineering college to carry out the detailed inspection to find out their cause & permanent solution of leakage, seepage and dampness in the entire building.
