### Reservation

Reservation to various categories viz SC/ST/OBC/EWS/PwD shall be given as per the Government of India (GoI) guidelines.

## **Age Criteria**

Minimum 18 years and maximum 27 years as on the closing date of the application form.

#### **Concession & Relaxation**

Concession & Relaxation is as per Government of India (GoI) guidelines for apprentices.

## Stipend

- The apprentices are eligible for monthly stipend as per Apprentices Act, during their period of engagement.
- II. The apprentices are not eligible for any TA-DA/Boarding or Lodging expenses incurred during the period of apprenticeship. The INFLIBNET Centre will not provide any financial assistance towards transportation.

#### Selection

Shortlisting/Screening/Selection will be based on the marks obtained in the respective discipline qualifying examination. Post screening of the online applications, shortlisted candidates will be intimated to appear for walk-in/online interview. The final merit list/Selection would be prepared according to categories General/SC/ST/OBC/EWS/PwD on the basis of performance by the candidates in the interview.

#### **General Conditions**

- 1. Candidates are advised to carefully read the full advertisement for details of eligibility criteria and selection modalities before submission of application.
- 2. The interested candidate must have a valid mobile number & E-Mail ID before applying for apprenticeship. The candidates need to register themselves on the apprenticeship portal at <a href="https://nats.education.gov.in">https://nats.education.gov.in</a> and are required to apply through this portal by finding the establishment INFLIBNET Centre and clicking the apply button on the next page.
- 3. Applications received online through NATS portal will only be considered. Correspondence/Communication in any other manner will not be entertained.
- 4. The number of candidates to be engaged is indicative and may undergo changes without any further notification.
- 5. During the period of apprenticeship, candidates will be governed by the Apprentices Act, 1961 (as amended in 1973 and till date) and the policies/rules of the organization.
- 6. Reservation for SC/ST, OBC and EWS as applicable in Government of India (GoI) will be followed.
- 7. INFLIBNET Centre shall have no obligation to offer regular employment to Apprentices during and/or after successful completion of the apprenticeship period, candidates will be relieved on completion of tenure.
- 8. The decision of management will be final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of the applications, mode of selection, cancellation of the selection process either in part or full, etc. No correspondence will be

- entertained in this regard. Filling up of the seats is solely at the discretion of the management based on suitability of candidates and no claim will be entertained, if some of these seats are not filled due to unsuitability/insufficient number of candidates.
- 9. INFLIBNET Centre does not take any responsibility to reply to the candidates for non-selection / non-issuance of call letter.
- 10. Candidates applying for more than one discipline will not be considered and their application will be rejected.
- 11. No Application Fee is being charged.
- 12. The candidature of the applicant would be provisional, subject to verification of all certificates and submission of certificate of Medical Fitness (to be obtained only from a Government Medical officer/Medical Officer of a Government Undertaking) at the time of joining.
- 13. The candidates should NOT have undergone Apprenticeship earlier or pursuing Apprenticeship Training as per the Apprentices Act, 1961, as amended from time to time.
- 14. Candidates, who had training or job experience for a period of one year or more after the attainment of prescribed qualifications, shall NOT be eligible for being engaged as Apprentice.
- 15. The applicant for the position should NOT have completed 5 years after passing of the qualifying examination as on the closing date of the applications. In case the date of Declaration of result is not mentioned in the Mark Sheet, the candidate must submit a certificate mentioning the date of publication of result from the Principal of the Polytechnic/College / Institute from where the candidate pursued his/her course at the time of verification of documents.
- 16. Applications/Registration which are incomplete or not fulfilling the eligibility criteria shall not be considered "Eligible" and treated as "Rejected".
- 17. At any stage of the selection process, if it is found that the candidate has furnished false or incorrect information, then the candidature/engagement of the candidate is liable to be cancelled.
- 18. Training for apprentices will be held at INFLIBNET Centre, Gandhinagar, Gujarat only.
