The Director's Report

I have the pleasure to present the Annual Report of INFLIBNET Centre for the period Ist April, 2001-31st March, 2002. During this period, the Centre has embarked upon significant activities and reached new heights of achievements. The entire set-up was reorganized into 8 functional Groups as detailed in Page Nos. 7 & 8 hereinafter keeping in view the relevance, application and the technological advancements that are taking place in the areas of Library and Information Science and Computer Science and Telecommunication Technology. Newer initiatives include decentralization of training programmes by way of organizing the regional library training programmes under INFLIBNET in every State.



Efforts were made to conduct inhouse training courses with new flavor and courses on interpersonal communication and managerial skills and advanced technological development were incorporated appropriately.

Specialised SOUL orientation training programmes were also conducted at Ahmedabad by inviting the professional staff of the universities who are handling the SOUL software.

Numerous distinguished scholars and experts in the above mentioned areas were invited by the Centre. Besides the above achievements, the prestigious annual convention CALIBER-2002, which was held in Jaipur, was overwhelmingly represented by large number of professionals from the state of Rajasthan and other parts of the country.

INFLIBNET also embarked upon usage of Hindi for day-to-day official transactions and training programmes. In order to keep abreast with the changing scenario, inhouse lecture series were introduced for the benefit of the Scientific and Administrative staff. The Centre also took up the important project of NISSAT-DSIR, Government of India, for creation of experts database in Science and Technology. Significant data has been collected and hosted on the Web in a record time under this Project.

Efforts were made to update the hardware and software wherever it was felt necessary.

The home page of INFLIBNET was also redesigned and hosted with a new look and feature. We strive to continue to serve the academic community with new vigour and vision.

The Scientists of the Centre geared-up their self in translating the vision for technological advancements into reality and contributed articles on the topics relevant to the activities of the organization. Further, they have presented a good number of quality papers at national as well as international level. The scientific talent exhibited and achievements made by the scientific personnel is praise-worthy. While appreciating the achievements of the scientific personnel, I wish to place on record my high appreciation for the outstanding services rendered by the Officers in Administration area and support provided by the subordinate staff for carrying out the activities and mission of the Centre. 4. Sh. S M Salgar (Acting Director 28-02-2001 to 31-05-2001)

Consequent on the retirement of Shri Pramod Kumar, who served INFLIBNET as a Director for two terms since its inception, Shri S.M. Salgar, Scientist - G, the senior most Scientist of the Centre took over as Acting Director of the Centre from 28th February 2001 to 31st May, 2001. During his tenure, the annual national convention - CALIBER - 2001 was successfully conducted in collaboration with University of Pune at Pune during March 14-16, 2001. Shri Salgar joined the erstwhile INFLIBNET in its formative stage and made significant contribution to the growth and development of the Centre.

5. Dr. TAV Murthy - New Director, INFLIBNET (01-06-2001 to -)

Dr. T.A.V. Murthy joined INFLIBNET as the Director on 1st June, 2001. He is the first Director from the Library Science profession to hold such a prestigious position of this national network. Dr. Murthy carries with him a rich experience and expertise of having worked and managed a number of libraries in many prestigious institutions in the country viz. Administrative Staff College of India, Hyderabad; Institute of Defence Management, Secunderabad; University of Hyderabad; Small Industry Extension Training Institute, Hyderabad; Indian Agricultural Research Institute, New Delhi; National Library, Calcutta; Indira Gandhi National Center for the Arts (IGNCA), New Delhi and Central Institute of English and Foreign Languages (CIEFL), Hyderabad. He also worked as a Post-Graduate Research student in his early days with Catholic University of America, Washington - DC and Casewestern Reserve University, Cleveland - Ohio, USA. During his association with all these institutions, he has done an outstanding work in introducing innovative services using the IT. Some of the highly noticeable contributions are setting up KALANIDHI Reference Library and Manuscript Information System, Multimedia Digital Project at IGNCA and Digital Laboratory at CIEFL. Dr. Murthy's contributions to these institutions in particular and the profession at large in the country are well known. He has been associated with number of universities in the country and has guided number of Ph.Ds and actively associated with the national and international professional associations. He has also been associated at quite a few committees at national level and has published good number of research papers. He has also been responsible for conducting number of innovative training programmes in the institutes wherever he has worked. Dr. Murthy has M.Sc. in Library Science from Catholic University, USA and Ph.D. in Library Science from the Karnatak University, Dharwad. He is a Fellow of Society for Information Science (SIS) and also presently president of this body. He is endowed with the extraordinary oratory skills and in-depth knowledge about the IT and scientific management of the libraries. He was also

as member of the core group which designed and architectured INFLIBNET in 1986. He has been on several U.G.C. committees relating to academic matters. Elected member of IFLA - Art Libraries (1992-94). Alumini of I.I.M. Ahmedabad. Visiting faculty of many universities besides member and chairman of board of studies of many library and information science departments in the university system. Visited over 22 countries during professional carrier.

6. New set of Universities Funded during 2001-2002

No Universities were funded.

7. Reorganization of Technical Activities at INFLIBNET

The basic objectives of the centre are to provide well needed computer based library information and communication services to the university community and other users in the country. The emerging technology, changing conditions and user needs are continually redrawing the lines of innovations thereby providing new challenges and opportunities. To meet the challenges, there was a need to restructure and expand centre's activities, transforming it to high performance and team based organization focusing on end results. In order to achieve the set objectives as a first step, the technical activities of the centre have been reorganized into eight major groups.

- Database Development & Maintenance Group seeks to address key issues in the library and information centre in the country to support and enable local library's collection in which India's heritage of intellectual property will be available at local, regional, national and international level. The group has responsible for creating and updating union catalogue of books, serials, theses, experts, projects and manuscripts database of Indian universities.
- Database R & D Group for creation of multilingual database, assisting participating libraries in database development activities for preparing quality database, conversion programmes on ISO to union databases, interface to download MARC and CCF data.
- Software R & D Group to take care of system analysis and design, including design prototype, library management software SOUL under different platforms, search engines for multilingual databases
- Informatics Group to mount all the union databases to provide access, providing various services of INFLIBNET including bibliographic, DDS, COPSAT, OCLC first Search, STN, CD-ROM based services, organizing Internet resources of academic interest and provide links, promotion of membership, SOUL, Publication.
- Human Resource Development & Consultancy Group for concentrating on conducting training courses, workshops/seminars, specialized courses, onsite training, tutorials, CALIBER, preparing libraries for automation, identifying universities for funding, follow-up assistance etc also taking care of centre's library.

- Networking, testing & Quality Control Group to coordinate UGC-NET, LAN, WAN, setup and maintain of INFLIBNET's Intranet. Provide assistance to university for LAN setup, physical networks security policy design for e-resource like servers, routers, modem etc. database administration and tuning, backup of database, web server system, disaster recovery, system maintenance, testing and quality control, testing of all resources etc.
- E-Learning Group for multimedia based multilingual SOUL tutorials on CD as well as on web, exploring various e-learning technologies, analysis, design and implementation of e-learning technologies on INFLIBNET site exploring various uses of Tele-conferencing and video conferencing in e-learning, use of multimedia in e-learning.
- Web Development Group covering INFLIBNET site objectives analysis, site design and updating. Maintenance of links and various web services running at the site. Maintenance of Intranet web site and also maintenance of INFLIBNET Library web site.

8. Human Resource Development (HRD)

Human Resource Development is considered as an important activity of the Centre. Success of library automation depends on suitably trained manpower. Variety of course were started for this purpose. One month fully residential training programmes were organised for the library professionals in use of computers and networking in libraries. Twenty such courses have been arranged till the end of the 9th Plan and more than 380 library professional from across the country have been trained. These courses were mainly meant for working level library professionals. Shorter, one week duration, workshops were also arranged for heads of libraries. Seven such workshops were held and more than 100 persons were trained. In addition, INFLIBNET staff visited a number of university libraries and conducted on-site training. Specialised training courses on SOUL software were also arranged at the Centre. INFLIBNET Centre, in collaboration with NASDOC/ICSSR also conducted two workshops for library professionals from social science institutes regarding library automation and use of Internet. Two such workshops were also conducted for the library professionals of Akashvani Kendras in collaboration with AIR Regional Training Centre. The Centre introduced a new series of regional level training programmes for library and information professionals called "INFLIBNET Regional Training Programme for Library Automation (IRTPLA)". These programmes were held at 13 places covering library professionals from the states of Kerala, West Bengal, Orissa, J&K, North-East States, Haryana, Punjab, Gujarat, Delhi, Maharashtra, Karnataka, Andhra Pradesh, Tamil Nadu and Goa. In order to accelerate library automation activities, Director of INFLIBNET conducted regional meetings at Nagaland University, Kohima; Panjab University, Chandigarh; Shivaji University, Kolhapur where librarians from neighboring states were invited.

a. 20th Training Programme Conducted

20th Training Programme on "Computer Application to Library and Information Services" (CALIS) was successfully conducted at INFLIBNET Centre, during September 10th to October 6th, 2001. This programme was specifically arranged to 19 universities funded during 2000-2001. This course was set in motion on 10th September, by Dr. R N Vakil, Dean, Centre for Environmental Planning & Technology (CEPT) and was presided over by Dr T A V Murthy, Director, INFLIBNET Centre.

During the four weeks programme the course had 38 lectures, of which 8 lectures were handled by invited resources persons and rest were handled by the faculty members from INFLIBNET. These Lectures mainly focused on the aspects relating to implementation of INFLIBNET programme in the respective libraries and recent trends in IT. Besides the lectures, more emphasis was given to practical sessions on

Basics of computers, MS Office Package, Operating systems, SOUL, Database creation using CDS/ISIS, CD-ROM Technology, Online Access, Internet, Webpage designing etc. Participants worked for a project on SOUL to develop more confidence in using this software. Participants were taken to visit a computerised library in the city. This programme was the 20th in the series and all the participants with this training will start creating their library holdings using the SOUL software, which is being purchased by these libraries.

b. Seventh workshop on "Automation and Networking of University Libraries Under INFLIBNET Programme"

INFLIBNET Centre has successfully conducted 7th Workshop on "Automation and Networking of University Libraries under the INFLIBNET Programme". This workshop was a first step for the new set of universities funded recently under INFLIBNET. A weeklong workshop was held for heads of these newly funded 19 university libraries during 25th June, 2001 to 1st July, 2001.

The workshop was inaugurated by Prof. Jeetendra Desai, Vice Chancellor, Gujarat Vidyapith and Dr. T A V Murthy, Director INFLIBNET Centre presided over the function. In his inaugural address Prof. Jeetendra Desai, highlighted the importance of library and library professionals in the research and development in the academia. He cited his own experience with the librarians. Dr. T A V Murthy speaking on the occasion emphasized the need for modernization of libraries and urged the librarians to adopt the new technology to handle the diverse information. He also said that, India is rich in its heritage and lot of knowledge and wisdom is available in the country, and we have to make this knowledge available to our research and academic community through the way of content creation. 18 participants from 18 universities participated in this workshop and took the benefit. This workshop was held as a part of series of human resource development programme of INFLIBNET.

There were 13 lectures in all and 5 of them were handled by invited speakers and the rest were handled by the faculty at INFLIBNET. These lectures mainly focused on various aspects relating to implementation of INFLIBNET Programme and recent trends in IT. Besides the lectures, the participants were exposed to Demonstration of SOUL (Software for University Libraries) - Library management software developed by INFLIBNET, access to Union databases developed at INFLIBNET, and browsing on Internet. A visit was also organized for the participants to a computerized library to give better insight on the automation activity.

Interesting feature of the workshop was presentation by the participants on the activities being carried out in their respective libraries and the action initiated by them in the successful implementation of the Programme. At the end of the workshop feedback session was also arranged where-in participants expressed their further expectations from INFLIBNET and their role in implementing project.

The concluding sessions was held on 30th June, 2001 at 1700 hrs. Dr. T A V Murthy graced the occasion and distributed the certificates. The participants of the workshop expressed gained enough confidence in proper implementation of the project.

c. AIR Workshop - 2002

A five day workshop on "Library Management in the Age of Computers" was organised at INFLIBNET from 7th - 11th January, 2002. This workshop was organised by the Regional Training Institute (Prog), All India Radio in collaboration with INFLIBNET Centre, Ahmedabad. This course was meant exclusively for the Librarians working in All India Radio Stations in four states viz. Gujarat, Rajasthan, Madhya Pradesh and Uttar Pradesh. It was attended by 22 participants.

The main objective of this particular workshop was to provide an exposure to the librarians in the area of application of information technology in AIR libraries. This was an intensive workshop devoted for imparting practical training.

d. ICSSR Workshop on "Access to Social Science Information in the Networked Environment"

A Five days Workshop on "Access to Social Science Information in the Networked Environment" was held at INFLIBNET Centre in collaboration with National Social Science Documentation Centre (NASSDOC), New Delhi (ICSSR) from 11-15 June, 2001. This Workshop was sponsored by Indian Council of Social Science Research, New Delhi and the Netherlands Foundation for the Advancement of Tropical Research, The Hague (WOTRO).

This workshop was held under the series of workshops that are planned by NASSDOC to be held in different parts of the country to create awareness about the Social Science Information usage. The response for the workshop was overwhelming and 24 participants took part in the workshop consisting of students, teachers and librarians who took active part in both lectures and hands-on-use of Internet.

e. INFLIBNET Regional Training Programme for Library Automation (IRTPLA)

At INFLIBNET, in the initial period, more emphasis was given for providing training to the university library staff. The libraries at the college level have now started taking initiative in the implementation of automation activities. INFLIBNET cannot conduct training courses for these libraries at INFLIBNET due to their sheer large number and also limitation of infrastructure at the centre. Since the universities covered under the programme have the infrastructure to conduct such training courses and also to cover the entire country at different places, four days training courses are being conducted at various universities.

Based on the recommendations made during CALIBER-2001 at Pune and with the overwhelming requests from all parts of the country, INFLIBNET Centre introduced a new series of regional level training programmes for library and information professionals, called as INFLIBNET Regional Training Programme for Library Automation (IRTPLA). Detailed action plan is worked out and sent to the hosting institutions. INFLIBNET provides financial assistance to conduct these training programmes. As a first step, this programme was conducted at 13 places in the country. IRTPLA is aimed at library professionals in college, university or research libraries at state level. For convenience and more attention, the number of participants is restricted to 20, with a limitation of one participant from one institute. The content of the course includes following topics:

- INFLIBNET activities and services
- Basics of computers, communication, networking technologies
- Library Automation Scenario in India
- Use of Internet in Libraries
- SOUL-Library management software developed by INFLIBNET
- Bibliographic Standards with reference to MARC 21

Sufficient time is provided to the participants in hands-on practical experiences in SOUL. State wise detailed report is being provided below.

Kerala

First ever programme in IRTPLA series was held for the state of Kerala at DLIS, Kerala University during October 29th November to 1st October 2001. Prof K. A. Issac, Former Librarian and DLIS-Head of Kerala University inaugurated the programme. 22 library professionals from various colleges and universities attended the programme At the concluding session, Prof Ramakrishnan, former head of DLIS distributed the certificates to the participants. Participants gave feed back about the programme and requested INFLIBNET to conduct more such programmes of this kind in future. Prof G. The workshops proved to be highly successful and motivational by improving the knowledge and communication skills of the employees tremendously. Sh D P Negi, Admin. Officer (P&A) of INFLIBNET was the Course Coordinator for these two workshops.

In-House Lecture Series

- A monthly in-house lecture series has been started at INFLIBNET for the benefit of its Scientific and Technical staff. Under this series, a lecture is delivered by a staff member on a particular topic related to IT; followed by group discussion.
- Dr T AV Murthy, Director inaugurated this new programme by delivering the first lecture of this series on "Internet Engineering in Libraries" on 31st July, 2001.

- Shri Suresh Panwar, Scientist-B delivered the second lecture in the series on "Video Conferencing and related technologies" on August 31, 2001.
- On September 30, 2001, Prof S K Kak, Professor, Banaras Hindu University & GB Member INFLIBNET visited INFLIBNET and discussed various issues related to the technical activities of INFLIBNET with the technical staff.
- Sh. V S Cholin, Scientist-B delivered another lecture on 31st October on "Formation of Library Consortia through INFLIBNET". All the lectures were very informative and all scientific and technical staff participated in the discussions.

9. INFLIBNET Regional Meetings

In order to accelerate library automation and related activities, Director of INFLIBNET conducted following regional meetings.

Nagaland University Library, Kohima

First meeting in the series was arranged for North East Region at Nagaland University Library, Kohima on 23 November, 2001. Prof. G. D. Sharma, Vice Chancellor, Nagaland University in his welcome address laid emphasis to strengthen the Library Networking though which academic and research community can update their knowledge. Dr. T. A. V. Murthy elaborated on the objectives and activities of INFLIBNET to the gathering comprising University Librarians from NE region. Librarians put forward their difficulties faced by them in automation and networking of their libraries. The meeting resolved that INFLIBNET should provide free training on SOUL and a document delivery Centre should be established in North East area. Director, INFLIBNET assured that training programmes and document delivery centers will be established depending upon financial and infrastructure back grounds.

Panjab University Library, Chandigarh

A regional meet of University Librarians, sponsored by INFLIBNET, was held at Punjab University Library, Chandigrah, on November 28, 2001 under the Chairmanship of Dr. T.A.V. Murthy, Director, INFLIBNET Centre. Librarians of Universities from Punjab, Haryana, H.P., Chandigrah, Jammu & Kashmir and Uttaranchal attended the meet. Dr. Murthy highlighted the challenges before the INFLIBNET and specified priority areas for the development of infrastructure facilities with regard to library automation, such as manpower training; R & D work including development and review of library software especially the SOUL package; and development of information services through e-learning. He announced that eight more Document Delivery Centres were to be set up shortly in different parts of the country. The agenda put forth by Prof. A. R. Sethi, Panjab University Librarian and Convenor of the Meet, set the issues for discussion. The University libraries were confronted with challenges like ageing equipment, enforcement of standards, erratic maintenance grants, manpower training, content creation, web-site creation and digitalization of special collections. Other issues like status of Document Delivery Service and non-representation of university librarians in the decision-making bodies of UGC and INFLIBNET also came up for discussion. The Director assured action on each of the issues raised by the participants.

A demo of SOUL software was given on this occasion, which invited crosscurrent of views. Realizing the fruitfulness and focus of this regional meeting, it was decided to hold such meetings at regular intervals in future.

Shivaji University Library, Kolhapur

In order to accelerate the library automation related activities in Maharastra, Karnataka, and Goa states, a regional meeting was held at Shivaji University Kolhapur on 27th December, 2001. Along with Dr TAV Murthy, Sh. SM Salgar and Sh. K Prakash from INFLIBNET Centre attended the meeting. Smt. Sumithra Jadhav, Librarian I/C, Shivaji University was the convenor for this meeting.

Discussion took place on the activities relating to automation, recruitment of Information Scientist, retrospective conversion, upgradation of systems, purchase of SOUL, Document delivery etc. Director informed about the UGC-NET. 16 university librarians were present for the meeting.

10. SOUL Software Related Activities

a. SOUL Orientation Programmes

Specialized SOUL orientation training programmes were conducted at Ahmedabad by inviting the professional staff of the universities in handling the SOUL software.

The first orientation programma for SOUL purchasers in the series was conducted from 3-5 December, 2001. 17 participants attended this programma.

The second programma was conducted from 25-27 February, 2002. 18 participants attended this programma. Shri B Ramesh, Scientist-B, INFLIBNET centre acted as the programma coordinator for both the programmes.

b. SOUL Evaluation

Several senior library professionals were approached to evaluate the SOUL software with a view to incorporate their suggestions in the new version. Accordingly, Dr. L. J. Haravu (Rtd. Manager, ICRISAT, Hyderabad) and Dr. S. R. Ganpule (Rtd. University Librarian of Mumbai University) offered their valuable observations, which were duly incorporated in the new version.

c. SOUL Demo Version Released

The SOUL software developed by INFLIBNET has become very popular and getting attention from all types of libraries at National level. There is an increasing demand for the demonstration of software from all corners, which is difficult to arrange at individual places. To encourage the use of SOUL software, INFLIBNET has released SOUL demo version, which will be available to libraries on request free of cost. The demo copy of the software has been sent to all library and information science departments to provide training on SOUL to their students. It is encouraging that many library and information science schools in the country included study of SOUL in their curriculum.

11. CALIBER: Convention on Automation of Libraries in Education and Research Institutions

In order to provide a forum for librarians to come together and discuss the issues and problems in automation and networking, the Centre holds a national annual convention at different places every year. These conventions address the current trends in information technology applications. Till today nine national conventions have been held at different places, first convention being held at Ahmedabad in 1994. This is an annual event held in different parts of the country in collaboration with a university in that region. This provides a unique forum for library professionals, information providers and users involved in automation and networking of libraries to come together and interact on the subjects of mutual interest. More than 300 professionals, on average, participated in each of these conventions.

CALIBER - 2002

The ninth Convention on Automation of Libraries in Education and Research Institutes (CALIBER) was inaugurated on Feb 14, 2002 by Shri Subash Mahariya, the Minister of State for Rural Development, Govt., of India at the HCM Rajasthan Institute of Public Administration, Jaipur, Rajasthan. Two hundred and sixty two library and information professionals from all over the country attended the event, sponsored jointly by the Information and Library Network (INFLIBNET) Centre, Rajasthan University and the Directorate of College Education, Govt. of Rajasthan.

The Convention started off on Feb 14, 2002 with Saraswati Vandana rendered by the students of the Department of Music, University of Rajasthan, followed by an introduction to INFLIBNET and CALIBER by its Director Dr T.A.V. Murthy. This was followed by an inspiring Presidential address by the Vice-Chancellor Prof K.L.Kamal, who called upon the librarians to contribute their mite in the task of transforming educational scene in the country. He also released the conference volume. The Minister of the state made an appeal to the librarians to reach out to rural areas. He also announced a package for the upliftment of rural libraries. Shri Saksena, Joint Director of College Education, Govt., of Rajasthan released the Souvenir. Prof Shabir Hussain, Dept. of Library and Information Science, Aligarh Muslim University, a senior professional, underlined how the absence of librarians in the top positions in university libraries was coming in the way of achieving the envisaged goals of INFLIBNET in modernizing the libraries. Prof Ashwini Kumar, Director, Rajasthan University Library and Organizing Secretary of CALIBER-2002 welcomed the delegates and proposed the vote of thanks.

On this occasion a very comprehensive and a thought provoking lecture on "Digital Library Technology" was delivered by Padmashree Awardee Prof N. Balakrishnan of the Indian Institute of Science, Bangalore, giving a panoramic view of the Knowledge Management of the future. The inaugural function came to close with an invigorating folk music and dance performance by the artists of Rajasthan Culture Department with assistance from Prof. Maya Tank.

The deliberations of the Convention were spread over two days, Feb 15 and Feb 16, 2002 in four sessions devoted to themes of 'Internet Based Library Management', 'Content Management', 'Internet in the changing education scenario', 'e-publishing and e-documentary sources' respectively. Each session had invited theme papers by an experienced librarian, having specialized expertise in the field. Out of the 100 papers including 50 in abstract form, which were included in the conference volume, around 50 papers were actually presented by the authors there of, some of which invited detailed discussion by the participants.

Dr. A R Sethi acted as the Rapporteur General and Smt. Lucy Bendang acted as the Associate Rapporteur General. The different sessions were chaired and reported by the following:

There were two presentations of information products made by the teams of Informatics India, Pvt. Limited, Bangalore and IBM, on Feb 15 and Feb16 respectively.

Prof K. L. Kamal, Vice-Chancellor of Rajasthan University was the chief guest for the concluding session and delivered the valedictory address. Dr Abhijit Lahiri (NISSAT), Dr H K Kaul (DELNET) and Dr T A V Murthy also spoke in the concluding session. Dr. A R Sethi, the Rapporteur General proposed the recommendations of the conference.

The following recommendations emerged out of the papers and the deliberations:

Recommendations for the librarians

- 1. With a view to bring all the universities into the mainstream of automation, this Convention calls upon the librarians to:
 - Frame time bound programme for database creation, latest by 2005.
 - Acquire and access material in electronic form, particularly the reference sources available in public domain.
 - To acquire necessary skills to exploit increasingly the potential offered by Internet access.
- 2. Considering the rapid development in the field of Information technology, which has influenced libraries and library services, this Convention implores the Departments of Library and Information Science in the country to upgrade the curriculum on the lines suggested by the UGC
- 3. The Convention calls upon the librarians engaged in content creation to evolve effective security systems for data protection, especially of indigenous origin.
- 4. With a view to conserve the already scarce resources, the Convention advises librarians to resort to consortia approach wherever feasible.

Recommendations for INFLIBNET

- 1. Considering that the SOUL as developed by INFLIBNET meets more or less all the requirements of the library management, the Convention recommends that INFLIBNET should ensure:
 - marketing of the SOUL in an aggressive manner all over the country;
 - provide a mechanism for support service;
 - institute diversified training facilities through Regional Centers, to be set up for the purpose
 - upgrade SOUL by incorporating the suggestions received from its users and provide more features in it;
 - incorporate the provision for creating databases of material in regional languages
- 2. Considering the need to bring college libraries located in rural areas at par with their counterparts in urban areas, this Convention recommends that special attention needs to be paid by providing them necessary infrastructure, and training facilities.

- 3. Taking note of the fact that, only about 50% of the university libraries in the country, have been covered under the INFLIBNET Programme, this Convention emphasizes the need to take rest of them under its ambit.
- 4. Since many agencies, such as NISSAT, NAAC, NASSDOC, DELNET are involved in creating Databases of Experts, this Convention recommends to INFLIBNET to coordinate these efforts to avoid duplication.
- 5. Since the document delivery service expected from the Document Delivery Centres, is not widely known in the academic circles due to lack of publicity and support, the Convention calls upon the INFLIBNET to give wide publicity to this service and provide backup grants for the purpose, and increase the number of Document Delivery Centres.
- The Convention recommends the establishment of INFLIBNET Regional Centers in different parts of
 the country for the purpose of helping the libraries in the region in computerization and creation of
 specialized databases, and for manpower development.
- 7. Considering that printed sources of information, periodicals in particular, are the mainstay for study and research, the Convention recommends that the INFLIBNET identify Resource Centres for supplementing their collection.
- This Convention recommends to INFLIBNET to sponsor series of lectures on specialized topics of the day, e.g. Intellectual Property Rights, Knowledge Management, and on other developments related to library and information services.
- 9. Promote training Programmes specially targeted at the use of Internet.

Recommendations for the UGC

- Considering the fact that majority of university libraries have vacant positions of university librarians, which is hampering their growth as well as the pace of modernization of libraries, this Convention calls upon the UGC to ensure that the top posts in the university libraries are filled up by March, 2003 positively, which is the time limit set by the NAAC for accreditation.
- Taking into account the ageing of infrastructure provided to some of the university libraries more than half-a-decade back, this Convention calls upon UGC to provide such libraries necessary funds to replace obsolete equipment.
- 3. The Convention implores the UGC to be prompt and regular in the release of non-recurring and recurring grants.
- 4. Taking note of the fact that adequate bandwidth for surfing Internet is a problem in many parts of the country, the Convention recommends that the emerging UGC Net is provided with sufficient bandwidth for accessing enormous data which is available and will be generated as more and more libraries come under the purview of the Network.

12. MARC - 21 Implementation at INFLIBNET

A committee was set up by Director, INFLIBNET to look into the implementation part of MARC-21 under the chairmanship of Smt. Sunita Murthy, Library of Congress, New Delhi. Committee consists of Dr. N G Satish, Administrative Staff College of India, Dr. B Ramesh Babu, Reader, University of Madras, Sh. Premchand, Sh. Yatrik Patel and Sh. Rajesh Chandrakar (Convenor) of INFLIBNET. The first meeting of the MARC 21 Core Group for identification and format preparation was held at INFLIBNET Centre on 24th September, 2001. After the brief report on SOUL modules, discussion took place for identifying and finalising MARC 21 fields for Books, Theses and Serials for incorporation into SOUL software. The discussion took place also on the use of name and subject authority files. It was decided to use the Library of Congress Name and Subject Authority files and create new authority files, only when it is required. The need for manuscript database creation by using the MARC21 standards was highlighted and the fields for the same were also finalised during the meeting.

The core-group discussed the use of Unicode for multilingual database creation and felt that the name and subject authorities could be developed on a pilot basis for one of the Indian languages and Hindi was selected appropriate at beginning level. Members also felt that printed guidelines should be prepared for the implementation of MARC21 at university level.

13. Status of two Projects

INFLIBNET has initiated following two new major projects during this period and is likely to continue in the next FY.

- 1. Retrospective Conversion of collection of five major libraries.
- 2. Document Delivery Service

These two project proposals were actually approved in 1998. Due to non-availability of sufficient grants, implementation got delayed by one year. These have been initiated to make an optimum use of existing resources and promote resource sharing among member libraries.

a. Retrospective Conversion of collection of five major libraries (Recon)

To avoid duplication in creation of databases, five major libraries were identified and given a project to complete in two years. This will bring in substantial savings, as the same data will be used for retroconversion of other libraries. Under the Recon project following five libraries will create good quality records of their entire holdings as per the standards recommended by INFLIBNET and contribute such records to union databases created at INFLIBNET in two years time.

Status of Retrospective Conversion of 5 Libraries (March 2002)

Name of University	Remarks
Banaras Hindu University, Varanasi	40,000 Input sheets prepared, 18000 records entered, using SOUL. The progress is very slow due to non utilization of grants before March, 2001. Has asked for extension of utilization of remaining amount. Need to speed up the work.
Indian Institute of Science, Bangalore	Not much has been done under the project. But the university has more than 1.5 lakhs of records in machine readable format using LIBSYS. Though this university has created records in machine readable form, they were created before the project was started. These records do not contain complete information and were suggested to use SOUL or update the records with complete details using the same package they are using. The response is very poor from this institution, which may be reviewed for further necessary steps.
Jawaharlal Nehru University, New Delhi	Around 60000 records are created and updated with subject headings. Used LIBSYS to create records. This university had started creation of records other than the subjects assigned. Later the record creation was continued in the subjects assigned. The problem with this university records is that, the records created and updated with subject headings are clubbed along with other data and separation of this data is required with the help of their software vendor. However they are asked to create separate database for new set of records after receiving the second installment of grants. The data entry cost per record fixed is not sufficient looking at the work involved in the data capturing which needs to be enhanced.
University of Madras	Created quality records. The number of records created in the first installment grant is 51,317 and were sent to INFLIBNET, using SOUL software. This university has shown keen interest in Retro-conversion work. As the university could utilize the grants in July 2001, asked for second installment grant to continue their work.
University of Mumbai .	Created quality records. The number of records created has reached more than 50000. Followed INFLIBNET guidelines using SOUL for database creation. This university has potentiality to complete the task of converting the records. However the progress made by them is comparatively slow. They have been advised to hire more people to accomplish the work as early as possible.

b. Document Delivery Service

To provide full text of serial articles available from the collection of university libraries, INFLIBNET Centre has setup six Document Delivery Centres. These libraries are also provided with funds to serve as Document Delivery Centres. This service is provided at cost and promotes resources sharing. Under the Document Delivery Service Project, following six universities, who have fairly large collection of serials, have been selected to serve as Document Delivery Centres:

Status of Six Document Delivery Service Centres

Name of University	Remarks
Banaras Hindu University, Varanasi	Purchased the equipment under the project viz. Magi color laser printer, scanner, Aerial software. Though the document delivery service was announced through INFLIBNET newsletter and other modes, the university has not received many queries. This is due to lack of awareness or interest among the academicians. Once the users are aware of the service, they will start using the service effectively. Proposed to send posters to university departments.
Indian Institute of Science, Bangalore	Not much is heard from this university in this regard. Though this university is processing the document requests as and when submitted, but against only advance payment. However it was made clear in the beginning that, universities may be allowed to pay on a quarterly basis for supply of photocopies. The university has not utilized the money fully as it has only spent Rs. 25,201/- against the total sanction of Rs. 535,000/- for both Retrocon and DDS.
Jawaharlal Nehru University, New Delhi	Purchased the equipment under the project viz Magi color laser printer, scanner, Aerial software. This university is processing the queries as and when the requests are received. The service has not taken the required momentum. INFLIBNET through its newsletter has sent out details again to make the service popular.

Panjab University, Chandigarh	Purchased the equipment under the project viz Magi color laser printer, scanner, Aerial software. This university has taken active initiative in providing the document delivery service. The services could not be very popular for the period due to lack of publicity and awareness among the users even after sending details to all the universities and publication through INFLIBNET Newsletter.
University of Hyderabad	Purchased the equipment under the project viz Magi color laser printer, scanner, Aerial software. This university has processed around 25 queries under the project. The services need to be made more popular for the effective use of the project.
Tata Institute of Social Science, Mumbai	Purchased the equipment under the project viz Magi color laser printer, scanner, Aerial software. Sent the utilization. This university has also taken active initiative in the project of document delivery service and utilized the grants. A number of request have been processed and TISS is taking active interest in the project.

14. NISSAT-INFLIBNET Project

"Developing and Managing a Web Enabled Database of Experts - Manpower Module in Science and Technology"

INFLIBNET has taken up a project on "Developing and Managing a Web Enabled Database of Experts - Manpower Module in Science and Technology" to create database of Experts in the area of Science & Technology of India. This is two years project funded by National Information System for Science and Technology (NISSAT), Department of Scientific and Industrial Research (DSIR), New Delhi. Under this project, INFLIBNET Centre has a mandate to compile and organize brief profiles of senior scientists, professors, readers and technologists working in the national laboratories, S & T department of central and state governments, institutions of national importance, universities and other R & D organizations. The database would be made available in the form of **EDST** (**Experts Database in Science & Technology**), which can be accessed from Vigyan server, Indian Institute of Science, Bangalore.

Status of the project

During the first year of the project, INFLIBNET has made remarkable progress and collected around twenty one thousand profiles from various institutions. In the first phase, INFLIBNET has spent most of the time in data collection.

Implementation

For the development of database and tools, initially CDS/ ISIS was used. Later on new tools based on three-tier architecture were developed. The database access and modification can be done using a web based client where the user is provided with a facility to register and create his/her own entry and subsequently modify his record. Bulk database can be entered and/or modified using a front end developed in Visual Basic, which provides the capabilities of registering, modifying the record, search based on specific criteria such as name, organization, specialization etc., status of database (like no. of experts entered, no. of

organization entered etc.), report generation, import/export database (from SQL to CDS/ISIS and vice versa), update master records and validation of the online entered records.

Web enabling

To enable the data on the web, INFLIBNET has developed sample web page which can be accessed from http://nissat.inflibnet.ac.in. It has been designed to publish and host the data on INTERNET. Sample web page of the database is given in figure below.

15. Governing Board Meeting

The 10th meeting of the Governing Board of the centre was held at UGC H.Q, New Delhi on 19th February, 2002. It was chaired by Dr. Hari Gautam, Chairman, UGC. Minutes of the 9th G.B. Meeting were confirmed. The members were briefed about actions taken by the centre on the items generated in the last GB meeting. Director presented the status report in respect of the centre. He also tabled a vision document. The Chairman invited comments from the members on this document within 15 days.

Proceedings of the 7th meeting of the Finance Committee and it's recommendations were studied by the GB. It approved non-plan grant of Rs.170 lakhs and plan grant of Rs.50 lakhs for R.E. 2001-2002. It also approved non-plan grant of Rs.200 lakhs and plan grant of Rs.70 lakhs for B.E. 2002-2003 as recommended by the FC.

The Director expressed difficulties encountered by the centre in installing SOUL and providing after sales service to a large number of academic institutions spread all over the country with limited man power available at the centre. He suggested franchising this activity. GB advised to bring a detailed proposal containing terms and conditions, finances involved, etc.

Director told that the centre would like to co-ordinate with reputed International publishers of journals for electronic subscription in consortia mode. The GB welcoming this suggestion suggested to start a pilot project and approved Rs.20 lakhs for the same. Director indicated that INFLIBNET would like to offer fellowships in the Inter-disciplinary library information sciences at the centre. Members suggested to induct 6 JRFs of the UGC for this purpose. GB also approved Rs.50 lakhs for starting the activity of creation of Indian databases. GB advised the centre to take suitable steps to make the 6 DDCs more effective. GB ruled out any increase in data entry charges for the libraries in the Retro conversion project.

GB approved appointment of M/s. T. N. Shah & Co. as the auditors for F.Y. 2001-2002. The auditor accounts of the centre for F.Y. 2000-2001 were placed before the GB. After detailed discussion, GB approved the account of the centre for F.Y. 2000-2001.

The Meeting then terminated with a vote of thanks to the Chair.

16. Awards and Honors to INFLIBNET Staff

Dr. T S Kumbar received Fulbright Fellowship in Information Science & Technology and named as Visiting Scholar in the OCLC Office of Research, U S $\bf A$

Dr. T S Kumbar, Scientist-D was named as OCLC Visiting Scholar for a six-month term beginning in August, 2001. He was chosen to receive Fulbright Fellowship in Information Science and Technology, which supports his research in the United States. The visiting scholar programme of the OCLC Office of Research aims to bring experienced scientists, educators and administers to OCLC. Dr. Kumbar, during his tenure studied the OCLC cooperative and identified how Indian libraries can successfully participate in the global library cooperative for the benefit of scholars and academia in India-and abroad. Dr. Kumbar is working with INFLIBNET Centre since December 1997.

Shri J K Vijayakumar selected as IFLA/OCLC Early Career Development Fellow 2002

In August 2001, International Federation of Library Associations and Institutions (IFLA) and Online Computer Library Centre (OCLC) selected five IFLA/OCLC Early Career Development Fellows for 2002 including Shri J K Vijayakumar, Scientific & Technical Officer, INFLIBNET from India. OCLC and IFLA established this fellowship to support library and information science professionals who are in early stages of their career development and from countries with developing economies. Under this programme Shri Vijayakumar will participate in a specially designed four -week programme in the United States during April 29-May, 24, 2002, based at the OCLC Institute in Dublin, Ohio. He is working with INFLIBNET Centre since November 1998.

The progress report was collected and discussed with the authorities for further course of action on the Recon work at these libraries. It was observed that there was a need to speed up the work. Discussions were held with concerned persons for the further course of action to overcome difficulties faced by them. Mr Cholin also visited Bangalore University during one of these days, to know the progress being made by this library in Automation. During his visit of JNU, Mr. V S Cholin also visited the Jamia Hamdard University, Kurukshetra University, Seth Jaiprakash Mukhand Lal Institute of Technology, Radur, Haryana and demonstrated operation of SOUL. Also necessary guidelines were given for proper implementation of INFLIBNET Programme.




