

CALIBER 2007 Report

The fourteenth in the series and 5th International CALIBER 2007 (Convention on Automation of Libraries in Education and Research Institutions) convention was organized this year in collaboration with Panjab University, Chandigarh during February 8-10, 2007. The theme was "Information and Knowledge Management in Networked World"

Tutorial

Mr. Yatrik Patel, Scientist-B (CS) INFLIBNET Centre, Ahmedabad, presented a pre-conference tutorial on "Building Digital Library using Open Source Software – DSpace". Around 80 delegates attended this tutorial and it was held during 9 AM – 10.50 AM on February 8, 2007.

Inauguration

Inaugural function of CALIBER – 2007 was held at the Panjab University auditorium on 8th February 2007 at 11.00 AM The Convention was inaugurated by His Excellency Gen. (Retd.) S F Rodrigues, Governor of Punjab and Administrator, Union Territory of Chandigarh. After Saraswati Vandana, Prof. R C Sobti, Vice Chancellor, Panjab University, Chandigarh welcomed the dignitaries on the dais and the delegates from India and abroad. In his welcome address, he emphasized the need for timely access to quality information. He appreciated the role of INFLIBNET Centre in providing elbow support to university libraries throughout India.

Speaking on this occasion, His Excellency Gen. (Retd.) S F Rodrigues said that although change is an effect of initiatives somewhere yet people have the tendency to resist change. There is a need for attitudinal change and the library and information services must be based on feedback from users. It is good to talk about knowledge management and National Knowledge Commission but we should also learn to focus our attention on application of knowledge. We must know what we are going to do with the available knowledge. Creativity, innovation and equity are the emerging issues need continuous attention. We must look beyond knowledge and become sensitive to information needs of respective communities. Our educational system must be spiritually and culturally very strong. There should be a shift from rote learning to critical thinking. We should follow holistic approach to put things together and emphasis must be on using information and knowledge for effective decision making.

Sh. Prem Chand, Scientist-C, INFLIBNET and Steering Committee Chairman of CALIBER-2007, briefed about the convention - its theme and sub themes. He further told that out of 160 papers received, 76 full text papers and 40 abstracts have been accepted for publication and presentation. A total of 400 delegates from India and abroad are attending this convention. Sh. Manoj Kumar K, Acting Director, INFLIBNET Centre highlighted the role and activities of INFLIBNET and expressed that it will have to initiate new programme to face the challenges of future and will play a major role in the light of recommendations of National Knowledge Commission. On this occasion, a souvenir and the conference proceedings were also released by His Excellency Gen. (Retd.) S F Rodrigues,

Governor of Punjab. Dr. V K Anand, Organsing Secretary CALIBER – 2007 and Librarian, A C Joshi Library, Panjab University, Chandigarh proposed vote of thanks. Mrs Jaspal Kaur, Librarian, Dev Samaj College, Chandigarh conducted the stage.

Technical Sessions

After the inaugural session, Prof K R Srivatsan, Director IIITMK, delivered the keynote address wherein he emphasized the need for interactive services to provide information to farmers. Prof. Shalini Urs, DLIS, Mysore University and Director, International School of Information Management, Mysore, chaired the session.

Following were the sub-themes of the convention

- 1. Digital Libraries
- 2. Information and Knowledge Management
- Innovations in Information and Communication Technology(ICT)
- Towards Virtual Libraries

In all, there were 8 technical sessions which were chaired respectively by Dr. P V Konnour, Dr. Devindar Kaur, Prof. Pravakar Rath, Mrs. Predepa Wijetunge, Dr. M K Bandi, Dr. S Majumdar, Dr. Ranjana Vohra and Prof. Jagtar Singh.

Mr. Ranjan K Barik, Mr. Vinod Garg, Mr. Rupak Chakravarty, Mr. M Maltesh, Mr. Umesha Naik, Mr. H G Hosamani, Mr. Rajesh Singh, Dr. Ashwini Tiwari, Mr. P Venkata Rao, Dr. Amar Nath, Dr. Payare Lal, Dr. Promila, Ms. Meena Jatana and Mr. Ajay Patil served as repporteur for these technical sessions.

Three theme papers were presented by Prof. Salini Urs, Ms. Kalpana Dasgupta, Dr. A R D Prasad respectively, where as the fourth theme paper could not be presented because of the non availability of Dr. Muttayya Kognuramath.

During the three days of the convention CALIBER Updates were brought out by the team consists of Prof. Jagtar Singh, Editor-in-Chief and Editors were Dr. Ashu Shokeen, Dr. Preeti Mahajan, Dr Trishanjit Kaur, Mr. H G Hosamani and Mr. Suresh K Chauhan

Dr. Ravi Gaddagimath, Librarian, Gulbarga University was the Conference Director and Prof. S L Sangam, DLIS, Karnatak University, Dharwad was the Rapporteur General for the "Technical Sessions" of the convention. Mr. K Prakash, Joint Convener, CALIBER-2007 and Scientific/Technical Officer, INFLIBNET acted as Conference Associate Director and Mr. H G Hosamani, Scientist B, INFLIBNET was the Conference Associate Rapporteur.

Valedictory Session

Mr. Randeep Singh Surjewala, Hon'ble Minister of Transport and Parliamentary Affairs, Govt. of Haryana was the Chief Guest of the valedictory function, Prof. R. C. Sobti, Vice Chancellor, Panjab University Chandiagarah, presided over the function. Dr. Ravi Gaddagimath, Director of the Convention shared his perception about the deliberation and proceeding of CALIBER-2007. Prof. S.L. Sangam presented comprehensive report of the Convention as well as 13 resolution adopted at the Convention Mr. Surjewala appreciated the resolution adopted by the Convention delegates and hoped that CALIBER-2007 would have been a rich learning experience for everyone. Prof. Sobti, in his presidential address thanked the INFLIBNET team for choosing Panjab University as a venue for the CALIBER-2007 and announced that in future also would love to host many more such Conferences. Mr. Prem Chand thanked the local organizers, Director of the convention, Rapporteur General, chairpersons and reporteurs of various technical sessions, authors, presenters, delegates and sponsors for their contribution and support. Besides Mr. Prem Chand, INFLIBNET Centre was represented by Mr. K. Prakash Joint Convener of CALIBER-2007. CALIBER Mementos were presented to the local organizers and foreign delegates. Dr. V K Anand, Organising Secretary and University Librarian, A C Joshi Library, Panjab University Chandigarh proposed the vote of thanks and Mrs. Jaspal Kaur demeanor the stage.

A colourful cultural evening of folk dance and music of Punjab was organized on February 8th evening. Prof. R C Sobti, Vice Chancellor of the university hosted the dinner for the delegates.

Dr. Sam Pitroda addressed during CALIBER -2007: A Report

The delegates of the CALIBER-2007 were indeed enthralled by an interactive Video Conference Session held on the 9th February evening. Mr. Sam Pitroda, Chairman, National Knowledge Commission (NKC) firstly addressed the delegates from Chicago and later on interacted with audience. In the beginning, he told about the mandate of the National Knowledge Commission and its composition as well. He further explained that the work of the Commission has been organized around five facets of the knowledge paradigm, i.e. Access to Knowledge, Knowledge Concepts, Creation of Knowledge, Knowledge Applications and Delivery of Services.

He underlined that access to knowledge is a prime concern of the Commission, Literacy, libraries, translation, language and knowledge networking are major areas of interest under this category. Knowledge sharing via networking must be order of the day. Under the 'Knowledge Concepts', overhauling of Indian education system is conceived by the Commission. School education, vocational education, open and distance education, professional education, i.e. medical education, legal education, management education and engineering education are thrust areas of this facet. The 'Creation of Knowledge' facet deals with intellectual property rights, innovation and development of science and technology for socio-economic development of the nation. The 'Knowledge Application' focuses upon agriculture and traditional knowledge. He said that just like telecommunication revolution in India, the benefit of the NKC would be visible during the next decade. There is strong need for diversity and holistic approach to the

emerging challenges in the 21st century. But diversity does not mean disagreement every time. Equity, diversity and flexibility can go a long way to ameliorate the Indian economy.

Under the 'Delivery of Services' aspect he explained the need for e-governance by making effective use of the ICT. With the help of the ICT, we can out reach the people at the periphery. He also explained the modus operandi of the Commission. He told that a three page letter has been sent to the Hon'ble Prime Minister of India. Then, there is a plan to discuss with the PMO Office, the implementation of the recommendations made by the Commission. During the third phase, discussions would be held with the Planning Commission and the concerned Ministries. He said that he is deeply committed to the development and use of the library and information infrastructure in India. He advised the delegates that they must make the cause of Library development in India a movement. He asked for quality feedback and suggestions on the recommendations made with respect to 'Access to Knowledge' aspect of the recommendations.

He shared his perceptions with the audience that people have tendency to resist change and majority of people want status quo. That attitude needs to be changed. Decisions are required to be made at the top to extend the benefits of knowledge services to the info-poor. These must be extended to the grassroots. Education, healthcare and sanitation must be the top priorities for us.

Public libraries in India have a pivotal role to play by serving as local gateways to knowledge. Community participation must be the backbone of the knowledge economy. A local library can not be managed from a remote place. Local community is required to take active interest in the development of public libraries. There is an urgent need for digitization of resources and than linking these resources through the proposed 5,000 nodes. He said 30,000 villages have fiber networking and access is now possible to the rural communities. Most important thing is the decision about what is to be digitized and how fast it is to be digitized. We must also learn to learn and adapt to the changing environment. We must rise above narrow political considerations and broaden our vision. Instead of focusing on personal benefits, we must focus upon public good. He recalled his sweet memories of his visits to Chandigarh, the city beautiful. Dr. S Majumdar, Librarian, University of Delhi enquired about the model to be followed for the National Commission on Libraries. Sam said we are not going to follow the USA model, but we are open to the best practices of any model. Dr. Ravi Gaddagimath, Director CALIBER - 2007 asked about the linkage between the recommendation of the Kothari Commission and the National Knowledge Commission. Sam said the vision and recommendation of the Kothari Commission are still valid. Dr. Jagtar Singh, Professor, DLIS, Punjabi University, Patiala asked about the ways to bridge the gap between the info-rich and info-poor. Sam told that by identifying with the local communities and using the existing infrastructure we can do a lot. If telecommunication revolution is an indicator, the recommendation of NKC would certainly facilitate digital inclusion in the near future.

Mr. Manoj Kumar K, Acting Director, INFLIBNET Centre also interacted with Sam from Ahmedabad through teleconferencing. This interactive video conference was really a rich learning experience for all. The delegates were able to

witness the power of ICTs to facilitate information communication and knowledge sharing, transcending traditional constraints of space and time. Towards the end, Dr. Ravi Gaddagimath, Conference Director and Dr V K Anand, Organising Secretary thanked Sam for sparing his valuable time for the conference delegates. News from the Divisions

UGC-Infonet

UGC-Infonet is an ambitious programme of University Grants Commission (UGC) for setting up nationwide highspeed communication network for Indian universities having 12B/12F status. Under this initiative, 149 universities have provided with the high-speed Internet connectivity through various mode of connectivity ranging from 256 Kbps to 2 Mbps raw. UGC-Infonet programme is successfully moving in to the next leap. The UGC has constituted a national level committee named Central Connectivity Monitoring Committee (CCMC) for smooth execution of this programme which is meeting regularly to discuss the issues related to the programme and releasing the guidelines to UGC and INFLIBNET for the process. Recently the committee met in Delhi and discussed the issues like Bandwidth enhancement, B/W subscription charges, Anti-Virus protection, additional connections etc.

As per the recommendations of the CCMC, the UGC had changed the pattern of funding to the UGC-Infonet Project since year 2005-06. In the new mode of payment the INFLIBNET Centre will be provided with the grants on behalf of the universities and the individual funding which earlier used to be provided to the universities individually was stopped. The centre is releasing payment after receiving of consolidated invoice for Bandwidth subscription charges from ERNET India, New Delhi and getting bandwidth certificate dully filled-in and signed by the Registrar and UGC-Infonet Contact person in prescribed format from the respective universities. The format of the certificate is a vailable at http://web.inflibnet.ac.in/UGC-InfoNet/files/BW format.pdf for download.

The Centre has already released the payment to ERNET India on behalf of the universities, who have submitted the bandwidth utilization certificates for the period of April-September 2006 and October 2006 to March 2007. In absence of the certificate, the Centre may not able to process the payment on behalf of the respective universities. Therefore, the universities are urged to provide the bandwidth utilization certificates to the INFLIBNET Centre on half yearly basis regularly so that there would not be any disruption in the network services.

Gravitation and Relativistic Astrophysics are the main areas of the research for Prof. Dadhich and he has published over 100 papers in international front rank journals in collaboration with many students and colleagues. He has visited several universities and institutes all over the globe. Prof. Dadhich has been elected to the Council of the International Relativity Society and nominated as Honorary Research Professor by the University of Natal, Durban, South Africa.

Prof. Rajeev Sangal is the Director of the International



Institute of Information Technology (IIIT), Hyderabad. He holds BTech(Elec.) from IIT Kanpur, and MS and Ph.D in Computer and Information Science from the University of Pennsylvania. Besides heading a new university, he also leads the largest academic centre on language technology in India, located at IIIT Hyderabad. His team is working

on machine translation systems from English to Indian languages. His work on machine learning combines statistical methods with linguistics structures for the processing of language. He has authored 3 books, and a

large number of research papers in NLP and AI. He is the President of NLP Association of India, and a member of the editorial board of Computational Linguistics, journal of ACL. He has also developed and successfully implemented a radical new curriculum in Computer Science and Engg., and Electronics and Communications that promotes research and project work starting from an early stage in the undergraduate level.


