

Subject: Minutes of the Pre Bid Meeting regarding Tender for Annual Rate Contract for Hiring Manpower and Security Services



06	Estimated Cost & GST	As the estimated cost for annum of the contract Rs. 4,32,00,000/-, whether it is including GST or excluding GST?	The mentioned estimated cost is excluding GST
07	Accommodation	Regarding provide of accommodation of the manpower whether it is client scope or bidder scope or individually they will arrange?	Provision of accommodation is not in the scope of the INFLIBNET Centre.
