INTRODUCTION

The Information and Library Network Centre (here after will be referred as INFLIBNET), is an autonomous Inter University Centre of the University Grants Commission, Ministry of Education, New Delhi. Sealed bids on behalf of Director, **INFLIBNET Centre, Gandhinagar** are invited under two bid systems i.e. Technical and Financial Bid. Sealed Tender for Security Auditing of Gap Analysis & IT Security Audit of INFLIBNET Centre must be as per terms and conditions attached.

Tender document and further amendments/corrigendum can be downloaded from the INFLIBNET Centre's website www.inflibnet.ac.in or from Central Public Procurement Portal (CPPP), Govt. of India website www.eprocure.gov.in and be submitted the same to INFLIBNET CENTRE on or before the due date of tender.

Bidder/Service provider is expected to examine all instructions, forms, terms & conditions, and specifications in the bidding document. Failure to furnish all information prescribed in the bidding documents or submission of bids not substantially responsive to the bidding documents in every respect may result in the rejection of the bid.

Scope of Work for Gap Analysis & Security Audit

INFLIBNET Centre has a Datacentre which hosts about 20+ physical servers hosting and about two dozen services. Few of the web based services are mission critical and nationally acclaimed projects such as NIRF, IRINS, ShodhGanga, eShodhSindhu, UGC website, e-scholarship maintenance, AIU Portal, etc. We are executing few of the services as per the directions of MHRD as well as UGC/AICTE.

We are in the process of upgrading the existing Data centre with standards and certifications. The basic purpose of GAP Analysis / security audit is to evaluate the existing Data centre and propose feasible solution for upgradation of the same so that, later, the Datacentre can be prepared for Tier II/Tier III/ISO 27002 Compliance. Before the upgradation of Data Centre, a GAP Analysis / security audit is planned which includes the following

- 1) Data Centre's physical security including Power, cooling, fire alarm & suppuration system, UPS & Battery etc.
- 2) Networked IT Infrastructure Security.
- 3) Power redundancy for Data Centre to avoid single power failure.
- 4) Uplink redundancy for the data Centre to make servers available 24x7.
- 5) Any other parameter which needs to be added/modified/removed to attain Tier III certification.

Deliverables and Audit Reports

The successful bidder will be required to submit the following documents in printed format (2 copies each) after the physical audit of the datacentre.

A detailed report with GAP Analysis status of Power, cooling, fire alarm & suppuration system, UPS & Battery etc. access of Datacentre (security). Reports will also include the all the essential parameters either exist at site or not and require to get Tier III/ISO 27002 certification of Datacentre.

Summary and detailed reports on security risk, shortcomings and audit with the necessary counter measures and recommended corrective actions to be taken.

The final GAP Analysis/ security audit certificate for the Datacentre should be in compliance with the Tier III/ISO 27002 standards for Datacentre.

The sealed envelope should be submitted to the In-Charge – (P&S), INFLIBNET Centre, INFOCITY, Gandhinagar or can be deposited/dropped in the tender Box placed at the security cabin, INFLIBNET CENTRE, INFOCITY, GANDHINAGAR-382007 on or before 23rd July, 2021 till 11:00 hrs., superscribing the enquiry number and due date.

- All the envelopes shall indicate the name and address of the bidder to enable the bid to be returned, if required.
- Late/delayed tenders shall not be considered. Therefore, please ensure that the tender is submitted/ posted well in time to reach us before the due date.
- Incomplete and conditional tender will be rejected
- The bid shall be written in English only.
- No other method/means of submission of bid except as stated above shall be acceptable. All entries
 in the bid form should be legible and filled clearly. Otherwise the bid is likely to be rejected. If the
 space for furnishing information is insufficient, a separate sheet duly signed by the authorized
 signatory may be attached. No overwriting or cutting is permitted in the Financial Bid form. The
 cuttings, if any, in the Bid/ Bid application must be signed by the person authorized to sign the bid.
- **02. Earnest Money Deposit (EMD)**: As per OM No.F.7/4/2020-PPD dated 12.11.2020 issued by Ministry of Finance, all the bidders are required to submit the Bid security Declaration Form as prescribed in annexure T-X. It is mandatory to submit the Bid security declaration Form, in absence of which the bid would be considered as unresponsive.

03. Performance Security Deposit: The successful Bidder/Contractor shall have to deposit a Performance Security Deposit of 3% of the total amount of work order immediately on the receipt of the LOI/Order. The performance security deposit will be furnished in the form of Demand draft/ Bank Guarantee/Banker's Cheque/Fixed Deposit of any scheduled bank drawn in favour of "INFLIBNET Centre" Payable at Gandhinagar. The performance security deposit should be valid for sixty days beyond the date of completion of all contractual obligations of the service provider under the agreement to be executed by and between INFLIBNET Centre and the service provider. Deductions shall also be made from Contractor's PBG during implementation of the contract that may become due as penalties for violation of rules, terms and conditions, damages, liabilities or for other causes. The performance security will be renewed, if the contract is extended.

04. Terms of Payment:

- 100 % payment will be released after submitting the final security audit certificate on completion of audit of website as per mentioned at scope of work, by e-transfer through RTGS/ NEFT. No advance payment will be made. The Contractor should provide their bank details duly signed by authorized signatories.
- Format of invoice is as per INFLIBNET (i.e. Tax invoice as per GST rules clearly indicating Tax registration number, Service Classification, GST number of both parties, rate and amount of Tax shown separately). The terms of such invoice(s) is that they shall be payable as per the rates submitted, negotiated and agreed by both.
- The Centre will deduct Income tax at source under Section 194-C of Income Tax Act from the renderer at the prevailing rates of such sum as income tax on the income comprised therein. All Taxes per applicable rules at time to time will be deducted at applicable rates from all payments made by INFLIBNET Centre. Necessary TDS certificate will be issued by the Centre.
- No claim for interest will be entertained by the Centre in respect of any payment/deport which will be held with the Centre due to dispute between the Centre & Contractor or due to Admin delay for the reasons beyond the control of the Centre.
- **05. Period of Validity of Offer:** For the purpose of placing the order, the proposals shall remain valid till 120 days. During the period of validity of proposals, the rates quoted shall not change. In exceptional circumstances, INFLIBNET may ask for extension of the period of validity and such a request shall be binding on Bidders. INFLIBNET's request and the response to such a request by various Bidders shall be in writing. A Bidder agreeing to such an extension will not be permitted to increase its rates.
- **06. Pre Bid Meeting**: Pre Bid Meeting will be held on 12.07.2021 at 11.00 hrs. at the premises of INFLIBNET. Only the queries received within the stipulated date prior to the Pre Bid Meeting will be answered.
- **07. INFLIBNET'S Right to reject any of all bids:** INFLIBNET reserves the right to reject any bid and to annul the bidding process and reject all bids at any time prior to award of Contract, without thereby incurring any liability to the affected bidder(s) or any obligation to inform the affected bidder(s) of the grounds for such decision. Any effort by a bidder or bidder's agent / consultant or representative, whosoever described to influence the INFLIBNET/ in any way concerning scrutiny / consideration / evaluation / comparison of the bid or decision concerning award of contract shall entail rejection of the bid.
- **08. Submission of Bid:** The bids have been invited under two bid system i.e. Technical Bid and Financial Bid. The interested bidders are advised to submit two separate sealed envelopes superscribing "Technical Bid" (Envelop 1) and "Financial Bid" (Envelop 2). Both the sealed envelopes should be kept in a third envelope of bigger size duly sealed and superscribed "Bid for Gap Analysis and IT Security Audit" to the INFLIBNET Centre, Infocity, Gandhinagar-382007 and shall be deposited/dropped in the tender box placed at the security cabin of the centre on or before the last date of bid

submission. Any Incomplete and conditional bids received shall not be considered and will be summarily rejected in very first instance without any recourse to the bidder and shall not be evaluated.

09. Price Bid: The price bids shall be opened on the scheduled time and date at INFLIBNET Centre, Infocity, Gandhinagar, in the presence of the representatives of the Housekeeping service Providers, if any, who wish to be present on the spot at that time.

The price bid of only those bidder will be opened whose bids have been found eligible as per the criteria mentioned in the technical bid (pre-qualification criteria envelop no.1). All eligibility conditions have to be satisfied on the respective date in such condition and not on a later date.

- 10. Termination of the Contract: The contract may be curtailed/terminated before the contract period, inter alia owing to deficiency in services or substandard quality of services by the empanelled agency etc. as may be specified in the contract to be signed between the parties. The INFLIBNET, however, reserves right to terminate this initial contract at any time after giving one month's notice to the selected Service Provider with or without assigning any reasons and shall be under no obligation whatsoever to continue the contract. Where a contract terminated by INFLIBNET on account of the default committed by the agency, it shall have the right to award the contract to any other agency at the cost, risk and responsibilities of contract and excess expenditure incurred on account of this will be recovered by INFLIBNET from his Security deposit or pending bill or by raising a separate claim.
- 11. Liquidated Damage: In the event of failure to meet the job completion in stipulated date/time liquidated damage may be imposed on the Bidder/OEM for sum not less than 0.50% of the contract value for that item/job for each week or part thereof, subject to a ceiling of 5 % of the total contract value/tender amount (including all taxes & duties and other charges). In the event of LD exceeds 5% of the order value, INFLIBNET reserves the right to terminate the contract and INFLIBNET will get the job completed by any other competent party. The difference of cost incurred by INFLIBNET will be recovered from the Bidder/OEM.

12. Resolution of Disputes:

The place of the arbitration shall be Ahmedabad/Gandhinagar, Gujarat. The Arbitration proceeding shall be governed by the Arbitration and Conciliation Act of 1996 as amended.

- **13. Relaxation of Terms and Conditions:** The Director, INFLIBNET is empowered to relax any term or condition mentioned herein.
- **14. Agreement:** The contractor will have to enter into a written Agreement with this Centre immediately after intimation/LOI. Thereafter only, work order will be issued to the bidder.

- **01.** Only those Organizations/firms registered with the CERT-in-empaneled are eligible for submitting the tender.
- **02.** The first round of GAP Analysis/security audit report should be submitted to INFLIBNET Centre within 45 days after the work order issued by INFLIBNET Centre.
- **03.** In case, the firm does not complete the audit work within the stipulated period from the date of confirmed work order, strict action will be taken against the firm.
- **04.** The tenderer can remain present himself/herself or his/her authorized representative at the time of opening the tender. Only authorized representative will be allowed to attend the meeting of the Tender Committee. They should also bring an undertaking on the letter head of the firm/organization that any decision/negotiation taken by their representative shall be acceptable to the firm.
- **05.** All the firms/organizations participating in the Tender must submit a list of their owners/partners etc. along with their contact numbers and a Certificate to the effect that the firm/organization is neither blacklisted by any Govt. Department nor any Criminal Case is registered against the firm or its owner or partners anywhere in India be attached with this tender. Any firm/organization blacklisted by a Govt. /Semi Govt. Dept. shall not be considered for this tender and tender will be rejected straightway.
- 06. The bidder must have accomplished atleast two types of similar work within the last five financial years, the details of which shall be mentioned at Annexure-T-VI.
