### **1.1. INTRODUCTION**

The Information and Library Network (INFLIBNET) Centre, an autonomous Inter University Centre (IUC) of the University Grants Commission, Ministry of Human Resource Development, Govt. of India, invites sealed quotations consisting of two-bid tender (Technical and Commercial) from eligible manufacturers/ authorized distributors/service providers for Comprehensive Annual Maintenance Contract of following Network Switches installed at INFLIBNET Centre Gandhinagar, Gujarat.

The bid document and further amendments can download from the INFLIBNET website (<u>www.inflibnet.ac.in</u>) or from Central Public Procurement Portal (CPPP), Govt. of India website (<u>www.eprocure.gov.in</u>) and submit the same to INFLIBNET Centre on or before due date of the tender.

Bidder is expected to examine all instructions, forms, terms & conditions, and specifications in the bidding document. Failure to furnish all information prescribed in the bidding documents or submission of bids not substantially responsive to the bidding documents in every respect may result in the rejection of the bid. Bidder must submit the technical and financial bid in prescribed format without ANY deviation.

### **GENERAL INSTRUCTION FOR BIDDERS**

#### 2.1 Eligibility Criteria:

The INFLIBNET has set up minimum eligibility criteria for the bidding purpose. All bidding parties must meet following criteria before they apply for the bid. The bidding parties meeting the criteria must enclose their supporting document photocopies along with the proposal as mentioned in Annexure T-I, failing which their bids will be summarily rejected and will not be considered any further.

### **2.2 Contract Period of Services:**

The contract will be awarded initially for a period of ONE YEAR extendable maximum up to 3 years on year to year basis or in part thereof as per the requirement of INFLIBNET and based on review of the performance of the services of Contractor/Agency with the same terms and conditions. The BG shall also to be renewed accordingly. The Contract/ Agreement is terminable by giving one month's notice in writing by either party to the agreement. The Centre reserves the right to curtail or extend the validity of Contract. The purchaser (INFLIBNET) does not recognize the existence of Sub-Contractors. The Contractor's responsibility is not transferable.

### 2.3 Period of Validity of Offer:

For the purpose of placing the order, the proposals shall remain valid till 90 days from the date of opening of tender. During the period of validity of proposals, the rates quoted shall not change. In exceptional circumstances, INFLIBNET may ask for extension of the period of validity and such a request shall be binding on Bidders. INFLIBNET's request and the response to such a request by various Bidders shall be in writing. A Bidder agreeing to such an extension will not be permitted to increase its rates.

### **2.4 Submission of Bid:**

The bidder has been submit proposal/bid of any section or every section as per their eligibility of pre-qualification criteria and scope of work under two bid system i.e. Technical Bid and Financial Bid. The interested bidders are advised to submit two separate sealed envelopes super scribing **"Technical Bids (Annexure T-I to T-VII)" and "Financial Bids (Annexure F-I)"**. Both sealed envelopes should be kept in a Third envelope of bigger size duly sealed suprescribed "Bid for Comprehensive Annual Maintenance Contract for Network switches" to the INFLIBNET Centre, INFOCITY, Gandhinagar. And also deposited/ dropped in the tender Box placed at the security cabin, INFLIBNET CENTRE, INFOCITY, GANDHINAGAR-382007 on or before 29.09.2020 at 17:30 Hrs.

### The bidder will have to ensure that the bid documents is available physical copy before last date.

#### Bid may be submitted in the following manner:

- **2.4.1** <u>Envelop No. 1</u>: Shall contain all the information and documents in the same serial order as shown in the Annexure–T-I (Pre-qualification criteria). The complete document should be numbered chronologically. On the top of envelope must be suprescribed "Technical Bid". Shall also contain the bid EMD.
- 2.4.2 <u>Envelop No.2</u>: Shall contain the rates/prices of the Services / items duly filled in Chapter 5 at Annexure F-I and signed and stamped. On the top of envelope must be suprescribed "Price Bid of Network switches".
- 2.4.3 <u>Envelope No.3 (Bigger Size)</u>: Bothe the envelopes must be suprescribed "Bid of Network switches" with due date and time and shall be sealed in third envelope of bigger size addressed to:

- **2.4.4** All the envelopes shall indicate the name and address of the Bidder/Contractor to enable the bid to be returned, if required.
- **2.4.5** Late/ or delayed tenders shall not be considered. Therefore, please ensure that the tender is submitted/ posted well in time to reach us before the due date.
- **2.4.6** Any Incomplete and conditional bids received shall not be considered and will be summarily rejected in very first instance without any recourse to the Bidder/Contractor and shall not be evaluated.
- **2.4.7** The bid shall be written in English only.
- **2.4.8** No other method/means of submission of bid except as stated above shall be acceptable. All entries in the bid form should be legible and filled clearly. Otherwise the bid is likely to be rejected. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Financial Bid form. The cuttings, if any, in the Bid/ Bid application must be initialed by the person authorized to sign the bid.
- **2.4.9** Duly filled Tender for qualification shall be submitted in proper format and incomplete offers shall be liable for rejection. Copy of each required documents should be submitted with technical bid for assessment.
- **2.4.10** Bids of those Bidder/Contractors who have submitted all information, statistical details as required in the bid documents. If the employer desires any clarification/ verification for any ambiguity or difference found in the documents/statistical details submitted by the Bidder/Contractor the same shall be furnished within stipulated time otherwise further processing will be carried out in absence of above and the Bidder/Contractors shall be liable for any consequence.

### 2.5 Earnest Money Deposit (EMD):

- **2.5.1** The interested Bidder/Contractor may put the tender document complete in all respects along with Earnest Money Deposit (EMD) of Rs.16,000/- (Rupees Sixteen Thousand Only) in the form of Demand draft/ Bank Guarantee/Banker's Cheque/Fixed Deposit of any scheduled bank drawn in favour of "INFLIBNET Centre" Payable at Gandhinagar and other requisite documents in the Tender Box kept near Security Cabin of INFLIBNET Centre, INFOCITY, Gandhinagar.
- **2.5.2** The bid securities of the unsuccessful Bidder/Contractors shall be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. No interest shall be payable by the Institute on EMD.
- **2.5.3** The bid security is normally to remain valid for a period of forty-five days beyond the final bid validity period. In exceptional circumstances, INFLIBNET may solicit Bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. The Bid security/EMD shall also be suitably extended. A Bidder granting the request is not required nor permitted to modify the Bid.
- **2.5.4** Exemption in EMD will only be given to Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or are registered with the Central Purchase Organization or the concerned Ministry or Department.

## **2.6** Forfeiture of EMD: EMD made by Bidder/Contractor may be forfeited under the following conditions:

- **2.6.1** If Bidder/Contractor withdraw the proposal before the expiry of validity period. During the evaluation process, if a Bidder/Contractor indulges in any such activity as would jeopardize the process, the decision of INFLIBNET regarding forfeiture of EMD shall be final and shall not be called upon question under any circumstances.
- **2.6.2** If Bidder/Contractor violates any of the provisions/terms and conditions of this proposal or indulges any such activities as would jeopardize the w0rk.
- **2.6.3** Accept the work order along with the terms and conditions.
- **2.6.4** In case of a successful Bidder/Contractor, if the Bidder/Contractor fails to submit the PBG in accordance with terms and conditions.

- **2.6.5** Submitting false/misleading information/declaration/documents/proof/etc. The decision of INFLIBNET regarding forfeiture of EMD shall be final and shall not be called upon to question under any circumstances, besides, forfeiture of EMD even the Bidder/Contractor will be deferred from participating in any job.
- **2.6.6** In the event of the successful Bidder/Contractor/contractor failing to comply with any provision of the contract.
- **2.6.7** The Bidder/Contractor shall not be allowed to withdraw or modify the offer on his own after the last date of submission of bid. If any Bidder/Contractor withdraws or makes any modifications or additions in the terms and conditions of his tender not acceptable to the INFLIBNET then the INFLIBNET shall without prejudice to any other right or remedy, be at liberty to forfeit the entire earnest money absolutely.
- **2.6.8** In case the Bidder/Contractor fails to commence the work specified in the tender documents within 15 days or such time period as mentioned in Purchase Order/Work Order/LOI, after the date on which INFLIBNET issues written orders to commence the work, whichever is later, INFLIBNET shall, without prejudice to any other right or remedy, be at liberty to forfeit whole of the earnest money absolutely.
- **2.6.9** In case of forfeiture of earnest money as prescribed as 1.6.1 to 1.6.8 above, the Bidder/Contractor shall not be allowed to participate in the retendering process of the work, if carried out.

### **2.7** Performance Security Deposit:

The successful Bidder/Contractor shall have to deposit a Performance Security Deposit of the 10 % of the total amount of work order immediately of the receipt of the LOI/Order. The performance security deposit will be furnished in the form of Demand draft/ Bank Guarantee/Banker's Cheque/Fixed Deposit of any scheduled bank drawn in favour of "INFLIBNET Centre" Payable at Gandhinagar. The performance security deposit should be valid for sixty days beyond the date of completion of all contractual obligations/warranty period. Bid security (EMD) shall be refunded to the successful Bidder/Contractor on receipt of performance security. The performance security will be renewed, if the contract is extended.

### 2.8 Pre Bid Meeting:

The Pre-Bid Meeting will be held on 17/09/2020 at 15:00 Hrs. at premises of INFLIBNET. Only the queries received within the stipulated date prior to the pre-bid meeting will be answered. Bidder can end their queries to:

The Service provider is expected to have visited the site before pre-bid meeting or submitting tender documents so as to have a fair idea of the CAMC of installed equipments at the Centre. The costs incurred by the Bidders in making this offer, in providing clarification or attending discussion, conferences or site visits will not be reimbursed by INFLIBNET.

### 2.9 Price Bid:

The Price Rates should be quoted separately for each section respectively. The price bids shall be opened on the scheduled time and date at INFLIBNET Centre, Infocity, Gandhinagar, in the presence of the representatives of the bidder, if any, who wish to be present on the spot at that time.

- **2.9.1** The financial bid of only technically qualified bidders whose bids have been found eligible as per the criteria mentioned in the technical bid Annexure T-I. All eligibility conditions have to be satisfied on the respective dates in such condition and not on a later date.
- **2.9.2** The Price Bid as per Performa given in the tender documents as ANNEXURE- F-I. Any conditions given in the price bid may cause rejection of Bid.
- **2.9.3** The GST charges should be provided spritely in financial bid, the GST or equivalent, as may be in force in future would be paid on actual basis at the applicable rate.
- **2.9.4** The prices should be quoted in Indian Rupees.
- **2.9.5** The Incomplete and conditional bids shall not be considered and likely to be rejected in very first instance.
- **2.9.6** The rates to be quoted for each section in figure as well as in words. (in case of dispute rates quoted in words shall be deemed to be correct)
- **2.9.7** All entries in the bid form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Financial Bid form. The cuttings, if any, in the Bid/ Bid application must be initialed by the person authorized to sign the bid.

### 2.10 Bid Evaluation Criteria & Award Criteria:

- **2.10.1** After the opening of the technical bid, the same will be evaluated by a committee, In case the committee decided for seeking further information/clarification, the same shall be provided by the bidder. Those bids which technically qualified as per prequalification criteria, and completed in all aspects with all annexures (T-I to T-IX) and meeting the requirements as specified in chapter-4, the financial bid of such qualified bidders will be opened on a specified date and time by the committee. The date and time of opening of financial bids will be intimated to the bidders well in advance through phone/email. The bidder is at liberty to be present either in-person or authorize, not more than one representative to be present at the time of opening of the financial bid. The Bids will be opened by the committee in the presence of the representative of the bidders who may wish to be present on that day.
- **2.10.2** In case it is found that the bidder has not quoted as per the requirement for any specified item that particular item shall be evaluated on the basis of highest quoted rates by the another bidder.
- **2.10.3** Any conditional bids received shall not be considered and will be summarily rejected in very first instance without any recourse to the bidder and shall not be evaluated.
- **2.10.4** The contract will be awarded for technically suitable lowest evaluated bidder whose bid has been found to be responsive and who is found eligible and qualified as per the tender document. In case two or more agencies are found to have quoted the same rates. The Competent authority of INFLIBNET shall decide about the bidder to which the offer shall be granted based on the report of the past performance of the firm, and length of experience etc. the decision of the Competent Authority of INFLIBNET shall be final.
- **2.10.5** The competent Authority of INFLIBNET is not bound to accept the lowest tender or any tender if found any technical discrepancies in the tender. The Authority reserves the right of accepting the whole or any part of the tender. The decision of the Authority in this regard shall be final and binding on the firm.

### 2.11 Terms of Payment:

**2.11.1** The BIDDER shall be paid quarterly payment after satisfactory services. Invoice must be attached with the register they maintain for Comprehensive Annual Maintenance Contract (CAMC) of Network Switches and signed with the Scientist in charge.

- **2.11.2** Format of invoice is as per INFLIBNET (i.e. Tax invoice as per Service Tax/GST rules clearly indicating Tax registration number, Service Classification, GST number of both parties, rate and amount of Tax shown separately). The terms of such invoice(s) is that they shall be payable as per the rates submitted, negotiated and agreed by both.
- **2.11.3** The payment will be made on quarterly basis by e-transfer through RTGS/ NIFT on submission of bill and scrutinized. No advance payment will be made. The Bidders should provide their bank details duly signed by authorized signatories.
- **2.11.4** No claim for interest will be entertained by the Centre in respect of any payment/deport which will be held with the Centre due to dispute between the Centre & Contractor or due to Admin delay for the reasons beyond the control of the Centre.
- **2.11.5** The Centre will deduct Income tax at source under Section 194-C of Income Tax Act from the renderer at the prevailing rates of such sum as income tax on the income comprised therein. All Taxes per applicable rules at time to time will be deducted at applicable rates from all payments made by INFLIBNET Centre. Necessary TDS certificate will be issued by the Centre.
- **2.11.6** During the currency of Contract. No increase in rates will be allowed.
- **2.11.7** Subject to any deduction which INFLIBNET may be authorized to make under the contract, the contractor shall be entitled upon the certificate of the Scientist in charge to the effect hereinafter stated payments of Bills shall be made to the contractor. The payment shall be made subject to availability of Fund/Grant/Letter of Credit.
- **2.11.8** If not replaced/replenished with the specified item. "INFLIBNET" or its technical consultant decision is considered to be final in case of dispute for any material or any product workmanship.

### 2.12 Amendment of Bid Document:

At any time prior to the deadline for submission of proposals, INFLIBNET Centre reserves the right to add/modify/delete any portion of this document by issuance of an Corrigendum, which would be published on the website and will also be made available to the all the Bidder who have been issued the tender document. The Corrigendum shall be binding on all bidders and will form part of the bid documents.

### 2.13 Enforcement of Terms:

The failure of either party to enforce at any time any of the provision of this contract or any rights in respect thereto or to exercise any option here in provided shall in no way be construed to be a waiver to such provisions, rights or options or in any way to affect the validity of the contract. The exercise by either party of any of its rights herein shall not preclude or prejudice either party from exercising the same or any other right it may have hereunder.

### 2.14 INFLIBNET Right to reject any of all bids:

The competent Authority of INFLIBNET reserves the right to reject any bid and to annul the bidding process and reject all bids at any time prior to award of Contract without thereby incurring any liability to the affected bidder(s) or any obligation to inform the affected bidder(s) of the grounds for such decision. Any effort by a bidder or bidder's agent / consultant or representative, whosoever described to influence the INFLIBNET/ in any way concerning scrutiny / consideration / evaluation / comparison of the bid or decision concerning award of contract shall entail rejection of the bid.

- **2.14.1** The Director, INFLIBNET reserves the right to terminate the contract without assigning any reason by giving a notice of 15 days to the Tenderer at any point of time during the period of the contract.
- **2.14.2** The competent Authority of the INFLIBNET reserves the right to annul bids or discontinue this tender process, without assigning any reason, at any time prior to signing of agreement with the successful bidder.
- **2.14.3** INFLIBNET reserves the right to vary/alter/amend the eligibility criteria for the Firefighting Service Provider at any time, in its discretion, before the last date submission of proposals.
- **2.14.4** By acceptance of this document, the recipient agree that any information herewith will be superseded by any subsequent written information on the same subject made available to the recipient with access to any additional information or to update this

document or to correct any inaccuracies, therein, which may become apparent, and INFLIBNET reserves the right at any fame and without advance notice, to change the procedure for the selection of service provider.

**2.14.5** The INFLIBNET reserves right to terminate the contract at any time after giving a one month's notice to the selected contractor with or without assigning any reason and shall be under no obligation whatsoever to continue the contract.

### 2.15 Termination of the Contract:

The contract may be curtailed/terminated before the contract period, inter alia owing to deficiency in services or substandard quality of services by the empanelled agency etc. as may be specified in the contract to be signed between the parties. The INFLIBNET, however, reserves right to terminate this initial contract at any time after giving one month's notice to the selected Service Provider with or without assigning any reasons. Where a contract terminated by INFLIBNET on account of the committed by the agency, it shall have the right to award the contract to any other agency at the cost, risk and responsibilities of contract and excess expenditure incurred on account of this will be recovered by INFLIBNET from his Security deposit or pending bill or by raising a separate claim.

### 2.16 Resolution of Disputes:

- **2.16.1** If any dispute arises between the Parties hereto during the subsistence or thereafter, in connection with the validity, interpretation, implementation or alleged material breach of any provision of the Agreement or regarding a question, including the questions as to whether the termination of the Contract Agreement by one Party hereto has been legitimate, both Parties hereto shall endeavour to settle such dispute amicably. The attempt to bring about an amicable settlement is considered to have failed as soon as one of the Parties hereto, after reasonable attempts [which attempt shall continue for not less than 30 (thirty) days], give 15 days' notice thereof to the other Party in writing.
- **2.16.2** In the case of such failure the dispute shall be referred to a sole arbitrator or in case of disagreement as to the appointment of the sole arbitrator to three arbitrators, two of whom will be appointed by each Party and the third appointed by the two arbitrators.
- **2.16.3** The place of the arbitration shall be Ahmedabad/Gandhinagar, Gujarat. The Arbitration proceeding shall be governed by the Arbitration and Conciliation Act of 1996 as amended.
- **2.16.4** The proceedings of arbitration shall be in English language. The arbitrator's award shall be substantiated in writing. The arbitration tribunal shall also decide on the costs of the arbitration procedure.
- **2.16.5** The Parties hereto shall submit to the arbitrator's award and the award shall be enforceable in any competent court of law.

### 2.17 Relaxation of Terms and Conditions:

The Director, INFLIBNET is empowered to relax any term or condition mentioned herein.

### 2.18 Agreement:

The contractor will have to enter into a written Agreement with this Centre within 30 days of intimation of acceptance of approved rates.

### 2.19 Disclaimer:

The near relatives of employees of the INFLIBNET are prohibited from participation in this tender. The near relatives for this purpose are defined as:

- Staff of INFLIBNET Centre
- Their husband or wife.
- The one is related to the other in the manner as father, mother, son(s), son's wife (daughter-in-law), daughter(s) & daughter's husband (son-in-low), brother(s) & brother's wife, sister(s) and sister's husband (brother-in-law).

### 2.20 Splitting of the contract and Curtailment of Work:

INFLIBNET reserve the right to split up and distribute the work among the successful bidders and to curtail any item of work in the schedule partly or fully.

### 2.21 Indemnity Bond:

- **2.21.1** The contractor shall keep INFLIBNET CENTRE and all officials of these offices indemnified from and against all suits, losses, claims, demands, proceedings, and liability of any nature or kind including costs and expenses, injuries to any person, damages to any property whatsoever, levy of fees or consequences which they may be put to or suffer on account of the services undertaken by the contractor.
- **2.21.2** During the performance of the contract, if the person(s) of THE BIDDER meet with any accident which results into the death or injuries to the person(s) of THE BIDDER or any damage made to the Third party and any claim or legal penalties arise out of it will be responsibility of THE BIDDER only. INFLIBNET will not be responsible in any way.
- **2.21.3** THE BIDDER shall follow all the regulations of Government of Gujarat and Government of India. THE BIDDER shall have any and all responsibilities of all the person(s) employed for the performance of the contract.
- **2.21.4** In the event of violation of any contractual or statutory obligations by the Contractor, he/she shall be responsible and liable for the same. Further, in the event of any action, claim, damages, suit initiated against the INFLIBNET by any individual, agency or government authority due to acts of the Contractor, the Contractor shall be liable to make good/compensate such claims or damages to the INFLIBNET. As a result of the acts of the Contractor, if the INFLIBNET is required to pay any damages to any individual, agency or government authority, the Contractor would be required to reimburse such amount to the INFLIBNET or the INFLIBNET reserves the right to recover such amount from the payment(s) due to the Contractor lying with the INFLIBNET

### 2.22 Force Majeure shall mean and be limited to the following:

- A. War / hostilities
- B. Riot or Civil commotion
- C. Earthquake, flood, tempest, lightening or other natural physical disaster.
- D. Restrictions imposed by the Government or other statutory bodies which prevents or delays the execution of the order by the BIDDER

During the term of this Agreement THE BIDDER agrees to maintain the EQUIPMENT in good working order and will bind to all conditions as stated below:

- 3.1 THE BIDDER shall correct any faults and failures in the EQUIPMENT and shall repair and replace worn or defective parts of the EQUIPMENT.
